Diamond APTF Fellow

With \$3,000 donation or a sixth \$500 donation individual is presented with a white gold APTF Fellow recognition pin set with a diamond stone.

Platinum APTF Fellow

With \$2,000 donation or a fourth \$500 donation individual is presented with a white gold APTF Fellow recognition pin set with a ruby stone.

Gold APTF Fellow

With \$1,500 donation or a third \$500 donation individual is presented with a gold-filled APTF Fellow recognition pin.

Silver APTF Fellow

With \$1,000 donation or second \$500 donation individual is presented with a sterling silver APTF Fellow recognition pin.

Bronze APTF Fellow

With \$500 donation individual is presented with a bronze APTF Fellow recognition pin.
